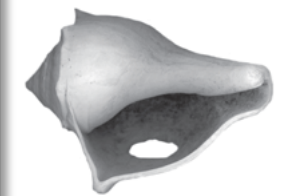

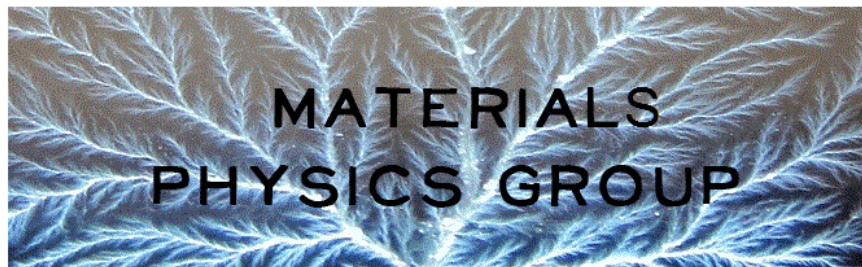

The Space Environment Effects Materials (SEEM) test facility operated by the Utah State University Materials Physics Group (MPG) is a leading research center for the study of space environment effects on aerospace materials. The MPG performs state-of-the-art ground-based testing of electrical charging and electron transport properties of both conducting and insulating materials, emphasizing studies of electron emission, conductivity, luminescence, and electrostatic discharge. Our efforts in this field over more than two decades—in cooperation with NASA, AFOSR, and numerous aerospace companies—have been primarily motivated by the space community's concern for charging of crafts caused by plasma environment fluxes and for radiation modification and damage of materials and components. We have studied how variations in temperature, accumulated charge, exposure time, contamination, surface modification, radiation dose rate and cumulative dose affect these electrical properties—or related changes in structural, mechanical, thermal and optical properties—of materials and systems. Our research also has direct application to high voltage direct current (HVDC) power and transmission lines, semiconductor metal-oxide interfaces, and nanoelectrics. Our research group consists of faculty, graduate, and undergraduate researchers. Publications and presentations are archived here.

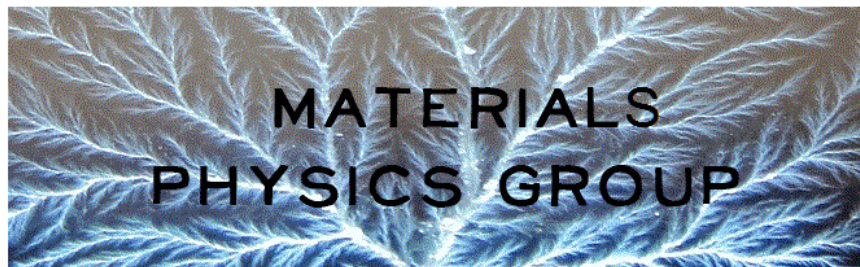

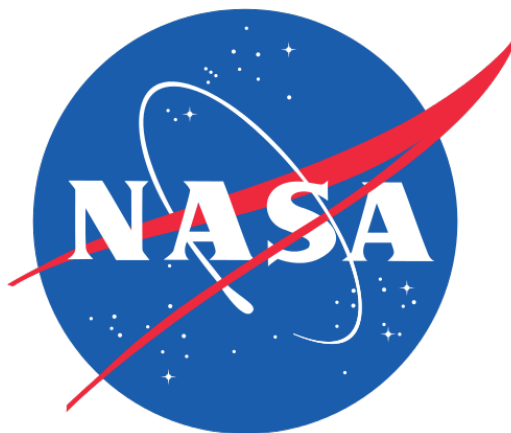

## Assessment

For the first time this year, we've provided benchmarking to its IR clients. Below are the numbers for 2013 and 2014.

### The College at Brockport

#### 2014 Benchmarking numbers

Growth: 1097 50<sup>th</sup>-80<sup>th</sup> percentile

Breadth: 52 80<sup>th</sup>-90<sup>th</sup> percentile

Demand: 108 80<sup>th</sup>-90<sup>th</sup> percentile

#### 2013 Benchmarking numbers

Growth: 856 50<sup>th</sup>-79<sup>th</sup> percentile

Breadth: 59 80<sup>th</sup>-89<sup>th</sup> percentile

Demand: 92 50<sup>th</sup>-79<sup>th</sup> percentile

#### Growth:

Calculates the number of full-text objects added during the calendar year in order to measure how much growth the IR is experiencing.

Highest: Literary Onomastic Studies (280); Education and Human Development MA Theses (208); Appointment, Promotion, and Tenure Documentation (91); English MA Theses (87)

#### Breadth:

Calculates the number of series/publications that have had 1 or more objects added to them over the course of the calendar year in order to measure the reach and engagement of the IR.

Lots of faculty publications and theses collections here, but also moves out beyond that into journals, books, yearbooks, administrative documents, technical reports, and conferences.

#### Demand:

Calculates the average number of downloads per object for the calendar year in order to measure the demand and interest in the content.

Theses and Dissertations seem to be getting the most downloads; the books that have full-text available are also doing really well; some of the CMST lesson plans are super high; a large number of the Kinesiology, Sport Studies and Physical Education Faculty Publications are doing very well; for journals, Spectrum and Philosophic Exchange are overall pretty high.

### Faculty success:

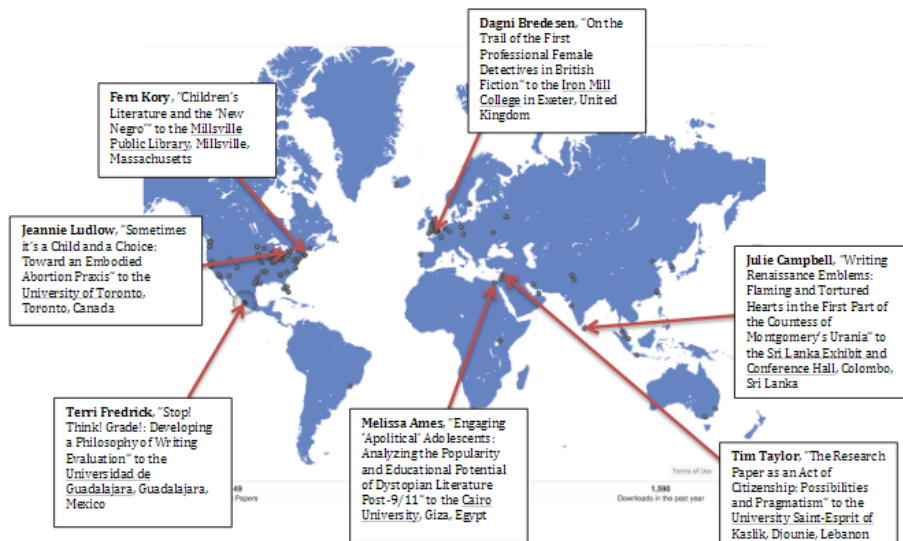


There are currently nine English faculty members participating in The Keep, for a participation rate of 19%.

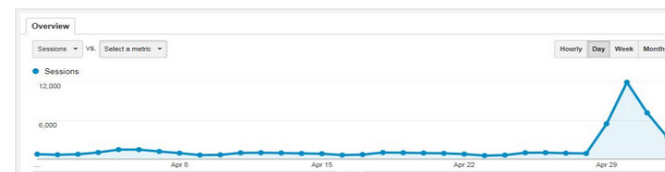

## When content goes viral: looking at the first 3 days of "Manly Health and Training"

On Friday, the *Walt Whitman Quarterly Review* (WWQR) published a previously unknown book-length work "Manly Health and Training," by Walt Whitman, recently discovered by Zachary Turpin. (Read more about it in a [previous post](#).) Minutes after it was published, *The New York Times* broke the story. (We couldn't say anything until their story launched at about 10AM, and the editors carefully timed publication to be minutes before the announcement.) From that point forward, we watched as the downloads of the content climbed. And yes, for some of us, this included watching over the weekend because it was very exciting!

The use was obviously high for the journal itself, but the use for our entire repository was massively spiked by this publication; over 91% of the traffic on our entire repository was for *Walt Whitman Quarterly Review*. This illustrates the typical use of our site from April 1–May 2 WWQR.



While the other items in the journal issue did not receive nearly as much use as the Whitman work and the introduction about the work, they received far more use than would be typical. Compare the first 3 days of use for a book review, bibliography, and back matter in this issue with similar items in the previous issue since being published.
