- 10 Regional Offices




• \$10.9 Billion annual budget in 2014

#### **FTA Grant Program Types**

- Formula Grant Programs
  - How much money a grantee receives is determined by a formula established in law
- Discretionary Grant Programs
  - Congress or FTA determines, at their discretion, how much money an individual grantee receives

# Highlights of FTA's Impact (cont'd)

#### Growth between 1995 and 2013

- 37% increase in transit ridership
- 20% growth in population
- 23 % increase in vehicle miles traveled

#### Federal Financial Assistance is Critical

 Fare Box Revenue Recovery Ratio of 20-30% for most Bus and Rail operations and much less for other transit modes
