ORDINANCE No. 155107

An Ordinance authorizing a Pioneer Courthouse Square Management Agreement with Pioneer Courthouse Square of Portland, Inc., an Oregon non-profit corporation for management of Pioneer Square and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Pioneer Courthouse Square, being Block 179 Portland, bounded by S.W. Sixth Avenue, S.W. Broadway, S.W. Yamhill Street and S.W. Morrison Street, is presently under construction as a City-owned public square.
2. That upon completion of construction it will be necessary to provide management and maintenance services for the square.
3. That the Pioneer Courthouse Square management advisory committee, the Portland Development Commission, the Bureau of Parks and the Commissioner in Charge of the Bureau of Parks recommend that management and maintenance of the square be undertaken by a non-profit corporation organized for that purpose.
3. That Pioneer Courthouse Square of Portland, Inc. is an Oregon non-profit corporation organized for the purpose of undertaking management and maintenance of Pioneer Courthouse Square and the Commissioner in Charge of the Bureau of Parks and the Portland Development Commission recommend that an agreement be entered into with Pioneer Courthouse Square of Portland, Inc., for management of the square for a period of one year subject to future renewals by agreement of the parties.
4. That the form of management agreement attached to this ordinance is an appropriate form of management agreement and should be authorized.

NOW, THEREFORE, the Council directs:


- a. The Commissioner of Public Affairs and the City Auditor are hereby authorized to execute on behalf of the City
